
“This wine exudes luxury. A wine of power and opulence, Aspire is made up of all but one block of Syrah grown on the property, with a beautiful lift from 13% Grenache. Housed for 22 months in 68% new French oak, it bestows impeccably integrated oak spice, vanilla, and clove, with concentrated primary blackberry, sweet black cherry, plum and blueberry fruit. There is tremendous complexity in this young wine showing hints of leather, graphite, cracked Szechuan pepper, with an almost villainous crimson core. Supple acidity and ample velvety-soft tannins accentuate the luxurious mouthfeel as the wine glides across the palate. The finish is long and sumptuous, with a peak in fresh acidity from Grenache, giving the power and density of this wine an effortless perception.”



“Audacious shows tremendous complexity and remarkable energy. The use of both our Cabernet clones, offers rich texture with ultra-fine-grained tannin and fresh herbal nuances. Grenache’s prevalent front-of-mouth entry bursts with bright red fruit, violets and white flowers that cascade over the mid-palate, where density from Syrah and Carignan, create a full-bodied mouthfeel. Having aged 22 months in 58% new French oak, this wine’s refreshing, and lengthy acidity, balance beautifully with the layered nuances of baking spices, vanilla, and woody char. Its energy and complexity are standout; providing a well painted picture of what the Law vineyard is capable of producing with a spark of inspiration from Priorat.”



“There is vibrancy throughout Beguiling’s palate weight, with stunning balance and freshness, through energetic acidity and remarkable fruit concentration. Arguably the most incredible version of this wine created in our history, we capture a seamlessly woven harmony of minerality, perfumed sage, garrigue, candied red fruit, cola and fresh flowers. Beguiling, not just by name but every sense of the word, spends 19 months in 45% new French oak, and just over a quarter of the final blend reared in Foudre and concrete egg, adding complexity through diversity in élevage. The loose-knit and all-encompassing tannins from Grenache, engulf the entire palate with bright vibrance, while the riper and opulently textured tannins from Syrah add to the body of the wine. Certainly, enticing in its approachability, while promising considerable longevity.”



“Beyond Category expresses a rich, velvety texture, bursting with black plums, a hint of chocolate, an array of savory umami flavors, and a touch of sage. This full-bodied wine carries high levels of finely powdered, “cheeky” tannins, along with a framework of beautiful acidity that Graciano contributes to the blend. Fermented at 60% whole cluster the Graciano also conveys a leafy tea, cinnamon, blackberry, and underbrush tone, accented by ripe red perfumed fruit from the Grenache and the impeccable balance and complexity of Carignan. A refined and evolved character has developed as a result of having seen 27 months in 60% new French oak.”



The 2021 vintage provided the perfect climate to achieve physiological ripeness and flavor development, resulting in a concentrated, dark and brooding expression of Petit Verdot. Blackberry, plum, African violet, and orange rind are complemented by a perfect touch of new French oak, which imparts notes of clove, vanilla, and a hint of char. Cabernet contributes an undertone of minty eucalyptus, while the palate experiences a gradual rise of ultra-fine, framing tannins that complement the more powerful tannins of Petit Verdot. Syrah delivers a full-bodied mid-palate, and perfect balance, accompanied by spiced intensity. The true magic of this wine--and the key to its tremendous longevity-- is the enthralling vivacity bestowed upon it by a perfectly harmonious yet sturdy backbone of acidity.”



“There is no mystery as to why Sagacious is so complex. Finding balance in the most expressive qualities from this classic Rhône trio, sourced from nearly all the Grenache, Mourvèdre, and Syrah blocks on the property. Sagacious saw 19 months in French oak, using large format puncheons and a Foudre, making the 38% new oak almost undetectable. This provides an unadulterated expression of the property. The markedly different tannin structure from each variety is brilliantly interwoven and integrated, providing a rich and full-bodied perception from entry, through to a long and lingering finish. Mourvèdre certainly makes its darker presence known with its blackberry, and gamey nature. Syrah’s presence is seen on the mid-palate, dense, with wild blue fruit, while Grenache adds bright red floral, and lifting high toned aromatics. Not leaving anything for the wanting, Sagacious is like a party that just won’t stop.”

“It unfurls slowly on the nose from red and black currant to wafts of rooibos tea, Angostura bitters, coffee beans and cocoa powder. 



With ample yet refined tannins, this opulent and full-bodied expression of Syrah is seamless and offers absolute pleasure in its youth with surprising approachability. Fantastic balance of acidity adds so much freshness and tension alongside the formidable structure of this wine. 


